President's Message

First, I would like to thank you for giving me the opportunity to serve CCBE as your 2017 President. I am thrilled to announce that CCBE has reached 100 percent membership! I am joined by a dedicated executive board and by our program manager, Charlyn Tuter and administrative specialist, Jenn Ng. Together we have brought some exciting programs and changes to our members.

One of my priorities this year has been on improving relationships. Superintendents and board members operate under a model of “shared governance” which could be represented by a Venn diagram. While each entity has been delineated specific responsibilities, the goal of their shared governance occurs in the area of the overlap. That overlap consists of student and district support, advocacy, and strengthening relationships with other elected officials. It’s been my experience that breakdowns usually occur in the board and superintendent relationship when there is not a good understanding of the balance that creates true governance.

The relationship between the county board and the county superintendent can be a delicate balance. Below are a few principles that I have found to be true in working with superintendents, partner organizations, and districts in our county that have resulted in a positive relationship:

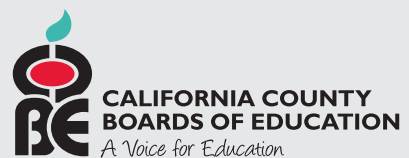
1. **Everyone is empowered to deliberate and make their own decisions.** It is the county board’s responsibility to provide support for the decisions the Superintendent makes within their authority. Regardless of what one may personally believe about the decision, each entity has the responsibility to support the independent decision making of the other.
2. **Top priority is given to preparing for board meetings.** A poorly run meeting is a reflection upon the board and the superintendent. Incomplete reports, deliberations off topic and single issue stances can result in a poorly run meeting that can hinder the reputation of the county office for which the superintendent and board share. It is in the best interest of both entities that board members are well prepared and that board meetings are well run.

CCBE Annual Conference 2017 Wrap-up

The 2017 CCBE Annual Conference, held in September, was a big success, with a total of 188 attendees. Overall, members found that sessions were very relevant and useful, and the presenters were excellent. Members enjoyed networking and having the opportunity to learn about what other counties are doing and appreciated gaining perspective on the political process and catching up on the latest technical and legislative issues.

The annual conference committee met at the beginning of the year and worked hard to bring CCBE members a conference that would be engaging and thought-provoking, and provide both in-depth and broad sessions to help with the decisions county board members must make to fulfill their mandated responsibilities. This year's theme was "**Prepare for Tomorrow**". We know that starting and sustaining a dialogue on the importance of education with state decision makers, local community members, and parents is key to the success of our students. With this thought in mind, the committee specifically sought presentations that highlighted best practices, engaged county board members and superintendents, and provided practical tools and replicable models in, among others, these important areas:

- Advocacy and its major impact on education policy, local control, and the funding provided to public schools, as well as anticipating and understanding the future political landscape's impact on education.
- LCFF/LCAP overview that provides guidance and tools to identify and seize opportunities to leverage investments in early childhood to improve children's outcomes in their communities.
- Charter schools and the county board's role in the authorization and oversight process for charter schools.
- Governance and the ability to understand and respect the different roles and best practices between county boards and county superintendents.
- Retirement security and its impact on schools and LCFF/LCAP funding for county offices of education.
- Social and emotional well-being and the unique challenges faced by students experiencing homelessness and how schools can remove barriers to homeless students' success.
- Innovation and student learning opportunities that help board members understand the keys to wise technology decisions and provide resources to help guide this process locally.

3. **Establish protocols for communication between the county board and the county superintendent early.**

Communication protocols can help keep everyone informed of potential controversial topics or requests for additional information. As a county board trustee, if you have questions or concerns, the first point of contact should be your superintendent.

4. **Establish a culture of “sharing the stage.”** We are all viewed as education leaders in the county. An important skill of an effective leader is to “share the stage” with others. You are an elected official, and in almost all cases,

so is your superintendent. Work with your superintendent to develop a plan that allows for everyone to highlight programs and talk with other locally elected officials, clubs and peers.

Many people do not understand the delineations in authority between the county board and the county superintendent. All they care about is that we are working together productively to provide a quality education to those we serve. We get the best results when our relationship is balanced by the responsibilities we perform independently with those we share. ■

cannot function effectively. Without your active participation CCBE cannot continue to be the strong organization that it is evolving into.

In addition to serving on CSBA's Delegate Assembly, regional county Delegates have a dual role and are automatically elected to also serve on the CCBE Board of Directors for a two-year term. The Delegate Assembly is a vital link in the association's governance and sets the general policy direction for the association. CCBE is a statewide organization that is a section of CSBA and partners with it in providing educational leadership serving the unique needs of all county boards of education in California. Through advocacy, training, mentoring, marketing and communication, CCBE serves and represents county boards in the education community, strengthening and promoting local governance, and enabling county boards to help every student succeed.

Members of the CCBE Board of Directors establish the vision, mission and goals for CCBE, and ensure that activities and programs remain focused on those goals and the issues identified in CCBE's policy platform. The CCBE Board of Directors is committed to serving an organization that is dedicated to equity and knowledge by being engaged, tenacious, and champions for education. Individuals who are committed and involved in providing educational leadership are needed.

CCBE Board of Director's roles and responsibilities include:

- Adopt CCBE's budget, policy platform, bylaws and standing rules.
- Provide two-way communication with local county board members and school districts.
- Select and endorse a candidate for the CSBA Director-at-Large, County position.
- Support and participate in CCBE's and CSBA's activities and events.

There are three required CCBE Board of Directors meetings each year. In 2018, the first meeting will be on May 20 following CSBA's Delegate Assembly meeting. The second meeting precedes CCBE's Annual Conference in September, and the third meeting will be on Nov. 29 in San Francisco following CSBA's Delegate Assembly meeting.
